Requirements of this application

To apply to register a political party, a minimum of 100 members of the party are required to support the application.

Tip: To prevent processing delays, it is recommended to have more than 100 members support the application.

Each member supporting the application must:

- » be enrolled on the Tasmanian electoral roll,
- » complete a statutory declaration confirming both their membership of the party and their support of the application to register that party,
- » have completed their statutory declaration no more than 12 months before lodging an application with the TEC.

Note: The *Electoral Act 2004* requires information provided on this form to be published in a notice in the *Government Gazette*, and in *The Advocate*, *The Examiner* and *The Mercury* newspapers.

Supporting documentation to be supplied with this form

Please provide a copy of the following documents to support this application:

- » a recommended 110 completed statutory declarations from members of the party,
- » a copy of the party's constitution documents (for example, written principles and rules that describe the formation of the party), and
- » if using the name of an existing party, written consent of that party.
