

Reportable political donation declaration

Electoral Disclosure and Funding Act 2023 section 49

What is a reportable political donation?

A reportable political donation is a political donation of \$1,000 or more. This may be a single political donation to an electoral participant or be multiple smaller political donations from the same donor to an electoral participant where the donations total \$1,000 or more.

What must be submitted with this form?

A disclosure of all reportable political donations for the applicable period must be attached and lodged with this form. The *Electoral Disclosure and Funding Act 2023* sets out specific requirements for what must be included in a disclosure. The Tasmanian Electoral Commission has provided a template that electoral participants may use, to help them to include all required information.

Who should use this form?

Any electoral participant who makes or receives a reportable political donation at any time must disclose the donation to the Tasmanian Electoral Commission. This includes: independent House of Assembly members or candidates, Legislative Council members or candidates, associated entities, third-party campaigners and significant political donors.

When to lodge this form

If a reportable political donation is made or received during an election campaign period, the donation must be disclosed and lodged with this form to the Commission **within 7 days** of the donation being made or received.

If a reportable political donation is made or received outside of an election campaign period, the donation must be disclosed and lodged with this form to the Commission **within the next one-month period** after the end of the calendar month in which the donation occurred.
