

# Legislative Council election campaign return

## *Electoral Disclosure and Funding Act 2023* section 84

### What is an election campaign return?

A Legislative Council election campaign return must be made by candidates after a Legislative Council election campaign period. A Legislative Council election campaign return is the disclosure of any political donations made or received, and election expenditure incurred (including disputed and unpaid claims against the candidate in respect of election expenditure) during a Legislative Council election campaign period.

### What must be submitted with this form?

The *Electoral Disclosure and Funding Act 2023* and the *Disclosure of electoral expenditure guideline* set out specific requirements for what must be included in an election campaign return for a Legislative Council election. The Tasmanian Electoral Commission has provided a template that Legislative Council candidates may use, to help them include all required information.

### Who should use this form?

A Legislative Council candidate who has incurred election expenditure and/or received a political donation during a Legislative Council campaign period must disclose their election expenditure and political donations in a Legislative Council election campaign return.

Other electoral participants are not required to complete a Legislative Council election campaign return. However, electoral participants may have donation disclosure obligations during the Legislative Council election campaign period – these disclosures must be made using the *Reportable political donation declaration form*.

### When to lodge this form

A Legislative Council election campaign return must be made **within 60 days** after the day on which the result of the Legislative Council election is declared. If an extension is required, please email the Tasmanian Electoral Commission prior to the due date to request an extension.
