## Second notice of failure to vote

Our records indicate that you appear to have failed to vote at the 2020 Legislative Council election for the division of <DivisionName>, which was held on Saturday 1 August 2020. Your address on the election roll was:

An initial notice was mailed to you in accordance with section 153 (1) of the *Electoral Act 2004* and to date a response has not been received. Voting compulsory. It is an offence to fail, without valid and sufficient reason, to vote at an election under section 181 of the *Electoral Act 2004*.

### If you did not vote

If you did not vote at this election, you have two options:

- » If you failed to vote without a valid and sufficient reason, you will need to pay a penalty of **\$34.40** by 12 October 2020, and no further action will be taken against you. Payment options are shown on the back of this notice.
- » If you believe that you have a valid and sufficient reason for not voting, provide that reason **on the back of this notice** and return it in the enclosed reply paid envelope by 12 October 2020.

### If you did vote

Please provide details on the back of this notice by Monday 12 October 2020 so that voting records can be rechecked, and corrected if necessary.

**If you do not respond to this notice of failure to vote, you may be issued with an infringement notice under section 157A of the Act and this will result in an increase in the penalty. Please find enclosed an explanatory brochure from the Monetary Penalties Enforcement Unit**
