Application for Registration of a Political Party

To apply to register a political party, a minimum of 100 members of the party are required to support the application.

Each member supporting the application must be enrolled on the electoral roll for Tasmania, and complete a statutory declaration which is to accompany this form. To prevent processing delays, it is recommended to have more than 100 members support the application.

All statutory declarations must have been signed and dated within 12 months of lodgement of this application form with the Tasmanian Electoral Commission (TEC).

Please provide a copy of the party's Constitution, or other documentation, to assist the TEC confirm the existence of the party.

A completed application may be lodged with the **TEC** at Level 3, 169 Main Road, Moonah, or posted to PO Box 307, Moonah, 7009.
