- 1: "Election expenditure" is defined in section 5 of the Electoral Act 2004.
- 2: Section 158 of the *Electoral Act 2004* provides for candidates to appoint an election agent. An election agent may incur or authorise expenditure on behalf of the candidate. The appointment must be in writing and signed by the candidate. Each candidate may appoint one election agent only.
